SON IN HOSPITAL IS LEFT ESTATES

Now Patient Where Parents Were Ill Short Time Ago

FEW AT BURIAL OF MURDERED WOMAN

While the body of Mrs. Marie Fiorelli, the murdered woman, was being buried in Greenwood Cemetery this morning, Alpha Fiorelli, her husband, and Attilio Condolera, who said to have lived her from her home, were in cells within a few feet of each in the Mercer County Jail, the former charged with murder and the latter as a witness.

Four friends followed her to the cemetery, with Coroner Bray. No religious service was held. Her two children did not even see the face of the mother. They were told to go to the morgue but did not arrive.

The police took extra precaution to keep the men under arrest as far apart as possible. They feared a clash might result.

Enrico Spero, of 37 Emory Avenue, the cousin of the slayer, was branded by Captain Detmar last night as the leader in the case to shield Fiorelli. His bail was fixed at \$3,000. The other men charged with helping the murderer to escape are Peter Bianchi, 154 Washington Street; Alfredo Tosti, 143 Whiting Street; and Antonio De Angelis, of 209 Mott Street. Counselor John H. Kafes represents Terlini, while Counselor Henry Wittstein is looking after the interests of the other men. These were held in \$2,000 bail each.

Condolera was placed under arrest last night at his boarding house by Patrolmen Pesse and Delonic. The policeman claim that he had a revolver in his possession at the time. He was held in \$1,000 bail. Dewey Jeanette was held in \$500 bail as a witness.

Samuel Levy, president of the Enterprise Cigar Company, where Mrs. Fiorelli was employed, and her brother, Peter Depasqua, yesterday made arrangements for the funeral. Mr. Levy claims that sufficient money among the employes for the purpose. The balance will be given to the City Relief Committee. ward labor. The Standard Oil king declared the best way to help the laboring man would be to give him better wages rather than charity, and added:

"I would be happy to surrender my holdings, in whole or in part, if the workers could come into the boards of directors and get the profits. I would be very happy to state that the workers were my partners."

"Did it ever occur to you that your foundations might become a menace to our democratic government?" asked Chairman Walsh. Mr. Rockefeller said he had no fear of that.

"Do you think that there is any tendency on the part of educational institutions which you have benefited to modify their courses of instruction on that account?"

"I have no occasion for anxiety in that respect."

"What means are there to prevent such a result?"

"I think I have relied upon the people, who are to watch constantly what use they are making of this power to prevent any misuse of the fund. It cannot be more interested in doing that than I am."

Aside from the letter of gift transferring \$100,000 to the Rockefeller Foundation, Mr. Rockefeller knew of no other deed to the money. He said he "had never worried" about the money reverting to himself or his heirs after his death. In case the legislature should revoke the charter.

"And I have great faith in the American people," he said, "in the people lies our protection."

ward labor. The Standard Oil king declared the best way to help the laboring man would be to give him better wages rather than charity, and added:

"I would be happy to surrender my holdings, in whole or in part, if the workers could come into the boards of directors and get the profits. I would be very happy to state that the workers were my partners."

"Did it ever occur to you that your foundations might become a menace to our democratic government?" asked Chairman Walsh. Mr. Rockefeller said he had no fear of that.

"Do you think that there is any tendency on the part of educational institutions which you have benefited to modify their courses of instruction on that account?"

"I have no occasion for anxiety in that respect."

"What means are there to prevent such a result?"

"I think I have relied upon the people, who are to watch constantly what use they are making of this power to prevent any misuse of the fund. It cannot be more interested in doing that than I am."

Aside from the letter of gift transferring \$100,000 to the Rockefeller Foundation, Mr. Rockefeller knew of no other deed to the money. He said he "had never worried" about the money reverting to himself or his heirs after his death. In case the legislature should revoke the charter.
